RE: Calendar Schedule up through April 17, 2020

Effective Thursday, March 19, 2020, Tulare County Superior Court will reduce the number of courtrooms opened for calendar matters. Below is an outline of that reduction:

## VISALIA DIVISION-CRIMINAL

- Calendars for Departments 3, 4, and 11 will be heard in Department 3. Judicial Officer to be determined.
- Calendars for Departments 5, 6, 10, 12 (Thursday calendar) and 14 will be heard in Department 6. Judicial Officer to be determined.
- Any no time waiver Preliminary Hearings and Jury Trials will be assigned to remaining vacant departments as needed. Judicial Officer(s) to be determined.

# VISALIA DIVISION-CIVIL

• Calendars for Departments 1, 2 and 7 will be heard in Department 1 by telephonic appearance only. Each judicial officer will preside over their department calendar pursuant to an agreed upon schedule.

## VISALIA DIVISION-FAMILY LAW

- Family Law matters scheduled in Departments 1, 2, 7, 8 and 9 will be heard in Department 9. Judicial Officer to be determined.
- Any mandated hearings will be heard in a vacant department. Judicial officer to be determined.

#### VISALIA DIVISION COLLABORATIVE COURTS

- Mental Health Court will proceed without participants on Thursday, March 19, 2020.
