# **Information and Instructions**

### **General Information:**

Under Health & safety Code §11361.8, a person currently serving a sentence, or who has completed a sentence for a conviction of a violation of section 11357, 11358, 11359, and 11360 of the Health & Safety Code may be eligible to have the conviction reduced or re-designated as a misdemeanor or an infraction and resentenced, or dismissed as applicable.

# Am I eligible?

If you were 18 years of age or over when charged with one or more of the violations listed above, you may be eligible to complete the Petition/Application for Resentencing or Dismissal, for Reduction or Dismissal/Sealing form and file it Criminal Operations in either the Visalia Division or South County Justice Center Division. Only one petition/application form should be completed per case.

If you were under 18 years of age when charged with one or more of the violations listed above, contact the Juvenile Justice Division.

# How do I know which section of the form to fill out?

(The definitions below are intended to provide general information and do not attempt to provide legal advice about how to submit your petition/application.)

If you have been convicted of one of the eligible violations	then
and are currently serving a sentence, under supervision (probation, parole, post release community supervision (PRCS), mandatory supervision) or in custody,	for purposes of this form, you may select <b>box 1A</b> and mark the applicable box(es) to indicate the action(s) to be taken on your sentence(s).
and have completed your sentence, are no longer under supervision (probation, parole, post release community supervision (PRCS), mandatory supervision) or in custody,	for purposes of this form, you may select <b>box 1B</b> and mark the applicable box(es) to indicate the action(s) to be taken on your conviction(s).
and are currently diverted pursuant to Penal Code Section 1000,	for purposes of this form, you may select <b>box 1A</b> and mark the applicable box(es) to indicate the action(s) to be taken.

# Where will the petition/application be heard?

If your case was heard or is being heard at the Visalia Division you will file your Petition/Application at the Visalia Division.

If your case was heard or is being heard at the South County Justice Center you will file your Petition/Application at the South County Justice Center.

#### How long does this process take?

The petition/application process may take up to 120 days or longer, depending on the details of the case and the amount of petitions received by the court.
