The Self-Help Resource Center (also known as the Family Law Facilitator) will provide instructions on how to complete the forms and how to properly serve notice on all the necessary parties. They can answer your procedural questions and explain the court process. The Self-Help Resource Center **CANNOT** represent you in court.

This is an instructional guide to filing a Petition to Determine Parental Relationship, designed to explain the necessary steps for filing your paperwork and obtaining an order of child custody and visitation and/or child support.

Fillable, printable pdf versions of the Judicial Council forms contained in this packet are available online at https://www.courts.ca.gov/forms.htm. You can type the forms and print them out for filing. You can also use a forms completion program at https://sharpcourts.org/paternityparentage/

If you have further questions or concerns regarding your custody and visitation case, you may wish to consult with an attorney, use the assistance of a paralegal or typing service, or do self-research at the Tulare County Law Library (on the ground floor of the Visalia Courthouse, with Law Library computer terminals also available in the Self-Help Resource Center in the Porterville courthouse) or on the California Courts' Self-Help website at https://www.courts.ca.gov/selfhelp-custody.htm. Select the Spanish icon at the right of the webpage for information in Spanish.

USE THESE FORMS TO OBTAIN A JUDGMENT OF PARENTAL RELATIONSHIP. ASK YOURSELF:

- ✓ DID BOTH PARENTS SIGN THE BIRTH CERTIFICATE?
- ✓ DID BOTH PARENTS SIGN A VOLUNTARY DECLARATION OF PATERNITY? (usually this is done in the hospital before the parents sign the birth certificate)
- ✓ IS THERE A JUDGMENT IN A CHILD SUPPORT CASE LISTING BOTH PARENTS?

IF YOU ANSWER YES TO ANY OF THESE QUESTIONS, STOP. YOU WILL NOT USE THIS PACKET.

INSTRUCTIONS

NOTE: Please read and complete all applicable forms thoroughly and follow all of the required procedures – failure to do so may result in the Court delaying or denying your request.

STEP 1

COMPLETE THE NECESSARY FORMS

This packet includes the following forms, which you will need to complete:

- **1. Summons** (Judicial Council Form # FL-210)
- 2. Petition to Determine Parental Relationship (Judicial Council Form # FL-200)
- 3. Declaration Under Uniform Child Custody Jurisdiction and Enforcement Act (Judicial Council Form # FL-105)
- **4. Proof of Service of Summons** (Judicial Council Form # FL-115)

*When filling out the forms, you are the **Petitioner** and the other party is the **Respondent**.

You will also need the **Request for Order** packet so that you can schedule a hearing to get custody and visitation and/or child support orders.

IF you want to ask for a child support order, please ask the clerk for two copies of the **Income** and Expense Declaration (Judicial Council Form # FL-150). You will need to complete one and leave the other one blank for service on the other parent.

There is a fee for filing these forms. If you would like to apply for a fee waiver, please request a **Fee Waiver** packet from the clerk.

STEP 2

MAKE COPIES OF REQUIRED FORMS

- 1. (Optional) One copy each of the Fee Waiver forms (FW-001) and (FW-003)
- 2. Two copies each:
 - a. **Summons** (FL-210)
 - b. Petition to Determine Parental Relationship (FL-260)

- c. Declaration Under Uniform Child Custody Jurisdiction and Enforcement Act (FL-105)
- d. Request for Order (FL-300)
- e. Income and Expense Declaration (FL-150) if requesting Child Support

STEP 2

FILE COMPETED FORMS AND PAY FEES

File the originals and the copies together in Room 201 in the Visalia County Civic Center courthouse or at the Clerk's service counter in the South County Justice Center in Porterville.

When you file your forms, he Clerk will write the date and time of your hearing on the Request for Order (FL-300). The clerk will keep the originals and return your copies to you stamped "filed." One of these copies is for you to keep and the other is to serve on the other party.

STEP 3

SERVE THE OTHER PARTY

"Service" means someone 18 years or older, **other than you**, will hand-deliver the forms to the other parent. You will need to have someone serve the following forms on the other parent:

- a. Summons (FL-210)
- b. Petition to Determine Parental Relationship (FL-200)
- c. Declaration Under Uniform Child Custody Jurisdiction and Enforcement Act (FL-105)
- d. Request for Order (FL-300)
- e. Income and Expense Declaration (FL-150) if requesting child support
- f. **Blank** Response to Petition for Custody and Support (FL-270)
- g. **Blank** Responsive Declaration to Request for Order (FL-320)
- h. Blank Income and Expense Declaration (FL-150) if requesting child support

The person who serves the forms must complete and sign the **Proof of Service of Summons** (FL-115).

STEP 4

FILE THE PROOF OF SERVICE

You **must** file the original and one copy of your **Proof of Service of Summons** after the other party is served. The Proof of Service tells the court that the other party received the forms and was legally notified of the court date.

File the original and one copy of the completed Proof of Service. The clerk will give you back your copy for your records. Keep this copy as proof that the other party was served.

You have **30** calendar days after this *Summons* and *Petition* are served on you to file a *Response* (form FL-220 or FL-270) at the court and have a copy served on the petitioner. A letter, phone call, or court appearance will not protect you.

STANDARD RESTRAINING ORDER

(Parentage—Custody and Support)

ORDEN DE RESTRICCIÓN ESTÁNDAR

(Paternidad—Custodia y Manutención)

Starting immediately, you and every other party are restrained from removing from the state, or applying for a passport for, the minor child or children for whom this action seeks to establish a parent-child relationship or a custody order without the prior written consent of every other party or an order of the court.

This restraining order takes effect against the petitioner when he or she files the petition and against the respondent when he or she is personally served with the *Summons* and *Petition* OR when he or she waives and accepts service.

This restraining order remains in effect until the judgment is entered, the petition is dismissed, or the court makes other orders.

This order is enforceable anywhere in California by any law enforcement officer who has received or seen a copy of it.

En forma inmediata, usted y cada otra parte tienen prohibido llevarse del estado a los hijos menores para quienes esta acción judicial procura establecer una relación entre hijos y padres o una orden de custodia, ni pueden solicitar un pasaporte para los mismos, sin el consentimiento previo por escrito de cada otra parte o sin una orden de la corte.

Esta orden de restricción entrará en vigencia para el demandante una vez presentada la petición, y para el demandado una vez que éste reciba la notificación personal de la Citación y Petición, o una vez que renuncie su derecho a recibir dicha notificación y se dé por notificado.

Esta orden de restricción continuará en vigencia hasta que se emita un fallo final, se despida la petición o la corte dé otras órdenes.
