












# Juvenile Delinquency








# Pretrial Drug Diversion




Chart reflects the number of Incompetent to Stand Trial referrals for both Misdemeanor and Felony cases




Family Court Services (FCS) and Child Custody Recommending Counselor (CCRC)



Walk In during COVID months = drop offs in person for review


Non-English – Total of all non-English patrons






# Employee Age Comparison

### Separation from Court Employment






### Reason for Separation






















# Interpreter Activity by Language
