Fee: Kevin G. Little charges \$400 per hour for mediation, with one hour of preparation billed per four hours of mediation. Therefore, the fee for a half-day mediation is \$2,000, and the fee for a full day mediation is \$4,000.

If a mediation goes beyond the allotted four or eight hours, the remaining hours will be billed to counsel after the conclusion of the mediation.
