Checklist

1. Complete form JV-570 – Request for Disclosure of Juvenile Case File

- o Specify what records are being requested.
- O Describe in detail the reason the records are being requested and why they are relevant to the proceeding or purpose for which you need to obtain them.

2. Complete form JV-571 – Notice of Request for Disclosure of Juvenile Case File

- Ocomplete the 'TO (names)' section and list all of the individuals who are to receive a copy of the notice.
- o Complete section 1 and 2 and sign and date the bottom
- 3. Print a blank copy of form JV-572 Objection to Release of Juvenile Case File. A copy will need to be provided to each individual who receives a copy of form JV-571.

4. Service

- The following forms must be served at least 10 days before you submit form JV-570 –

5. Filing Documents with the Court

- After you have served form JV-570, JV-571, and a blank JV-572, you will complete form JV-569 Proof of Service Request for Disclosure and submit the following documents to the court clerk:
 - ✓ A **completed** form-570 Request for Disclosure for Juvenile Case File
 - ✓ A **completed** form-571 Notice of Request for Disclosure of Juvenile Case File
 - ✓ A **completed** form JV-569 Proof of Service Request for Disclosure
 - ✓ A **blank** form JV-573 Order on Request for Disclosure of Juvenile Case File (only complete the case name and case number)
 - ✓ A **blank** form JV-574 Order After Judicial Review (only complete the case name and case number)

There are no filing fees for these documents.

The court clerk will submit the documents to the judicial officer who will carefully review and consider your request. The judicial officer may grant, deny, or set your request for hearing. If the matter is set for hearing, the court clerk will provide notice to you and all parties.
